

USE AND ENJOY MAGENS BAY.

- 1. ALL GROUPS OF CHILDREN <u>MUST</u> HAVE PROPER ADULT SUPERVISION AT ALL TIMES. A RATIO OF 1 ADULT TO 5 CHILDREN IS MINIMUM.
- 2. ADULT SUPERVISION WILL MEAN KEEPING A WATCHFUL EYE ON CHILDREN IN THE WATER AS WELL AS OUT OF THE WATER.
- 3. THE LIFEGUARD HAS ABSOLUTE AUTHORITY WITH REGARD TO WHAT GOES ON IN THE WATER AND IN HIS AREA ON LAND.
- 4. THE ADULTS RESPONSIBLE FOR THESE CHILDREN MUST UNDERSTAND THAT THEY ARE HERE TO WATCH THE CHILDREN CLOSELY, NOT TO "LIME" ON THE BEACH!
- 5. THE LIFEGUARD WILL DETERMINE, FROM THE SIZE OF THE GROUP, HOW MANY ADULTS MUST BE IN THE WATER WITH THE CHILDREN, AT ALL TIMES!
- 6. IF THERE ARE ANY SPECIAL CHILDREN IN THE GROUP THAT PERHAPS NEED MORE ATTENTION, WE SHOULD KNOW ABOUT THIS IN ADVANCE.
- 7. ANYONE TRAINED IN FIRST AID/CPR SHOULD BE INCLUDED IN THE COUNSELOR'S GROUP!
- 8. NO BOTTLES ARE ALLOWED; NO PLASTIC SANDWICH BAGS. (THESE CAN BLOW INTO THE WATER AND KILL FISH AND TURTLES).
- 9. HAVE THE KIDS IN THE GROUP PICK UP THE TRASH, BAG IT, AND LEAVE IT IN A CENTRAL LOCATION!
- 10. TREES ARE VERY IMPORTANT TO OUR ENVIRONMENT. NO ONE SHOULD DESTROY TREES, LEAVES, BRANCHES, AND FRUITS, ETC. ON MAGENS BAY PROPERTY!

The state of the s	, HEREBY AGREE TO THE FOLLOWING IDITIONS AND RESTRICTIONS SET FORTH BY THE MAGENS BAY (MBA) FOR OVERNIGHT CAMPING ON THE GROUND SITE:
1.	No bottles are allowed! All beers, soft drinks, malts, etc. must be in cans!
2.	Absolutely no generators are allowed!
3.	Operating hours of Magens Bay Authority is from 8:00 A.M. to 6:00 P.M. daily. Power will be provided only at this time. Night parties are not allowed!
4.	Cleaning up your area and bagging of trash is helpful for us all! All trash must be disposed of before leaving the camp site.
5.	$\underline{\text{No fire pits}}$ are allowed on the beach area, portable grills only. Do not dump hot coals on the sand.
6.	A copy of liability insurance for the entire group must be attached to the application form.
7.	No benches should be removed from the beach area and placed in the camping ground.
8.	The bathrooms are closed at 6:00pm. However, prior arrangement can be made with management to accommodate parties of less than ten (10). Ten (10) persons or more, portable potties will be mandated.
